RE: 2010 dog licensing requirements

Did you know that city and county ordinances require all dogs older than 4 months living within the city limits or the county's dog-control zone to wear a current license tag? Even dogs that primarily live indoors are required to be licensed.

YOUR PET'S ID Licensing is designed to help ensure the safe and timely return of pets to their owners. Your dog's current license enables local authorities to identify your pet and also identifies you as the dog's owner. About 95 percent of lost animals that wear current identification are reunited with their owners. Ownership of a pet can be difficult to prove if the pet is not wearing current tags.

REGISTER YOUR DOG In order to make the licensing process as easy as possible, we've attached a brief form for you to fill out and return to us. Please duplicate the form if you have more than one dog. Licensing forms are also available at all local veterinary clinics and at the Blue Mountain Humane Society. Local ordinances require that all dogs have proof of a current rabies vaccination.

WHEN A PET IS LOST As a reminder, if you lose your pet, please report it immediately to the following local authorities. Even if you are not a pet owner, you may find the following contact numbers helpful if you find an animal or experience animal problems in your neighborhood.

Dog license order form

Proof of alteration and rabies vaccination must be provided. Please enclose a current rabies vaccination certificate or the name and phone number of your pet's veterinarian, and make checks payable to BMHS. Mail to **7 E. George St., Walla Walla, WA 99362**. City dog licenses for 2010 cost: • \$30 for an unaltered dog (not spayed or neutered). • \$15 for an altered dog (proof required).
